Why it is important to study?

- to consider transformations of the right for freedom of faith in the modern Russian society
- to show the results of questioning

Do the students have the right to wear religious clothes or attributes in public schools?





Tasks and questions of research:

- to study the judicial practice of ensuring religious rights in the educational process
- to analyze the results of authentic public opinion
- ✓ *What is your attitude to student's right to wear religious attributes in the educational institutions?*
- ✓ *Are the interests of the representatives of your nationality in Russia protected?*
- ✓ *Do you think that the right to wear religious attributes and perform religious ceremonies in the educational institutions contradict with the federal legislation?*
- ✓ *Do religious attributes infringe the rights and freedoms of other people?*
- ✓ *Does the administration of the educational institution have to take into account religious rights of students?*

- ✓ questioning



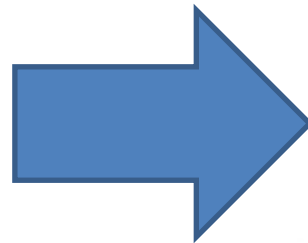


What is your attitude to student's right to wear religious attributes in the educational institutions?

61.1 % feels indifferent in relation to this question

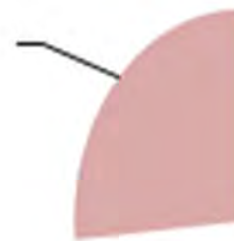
Are the interests of the representatives of your nationality in Russia protected?

No; 16.7%

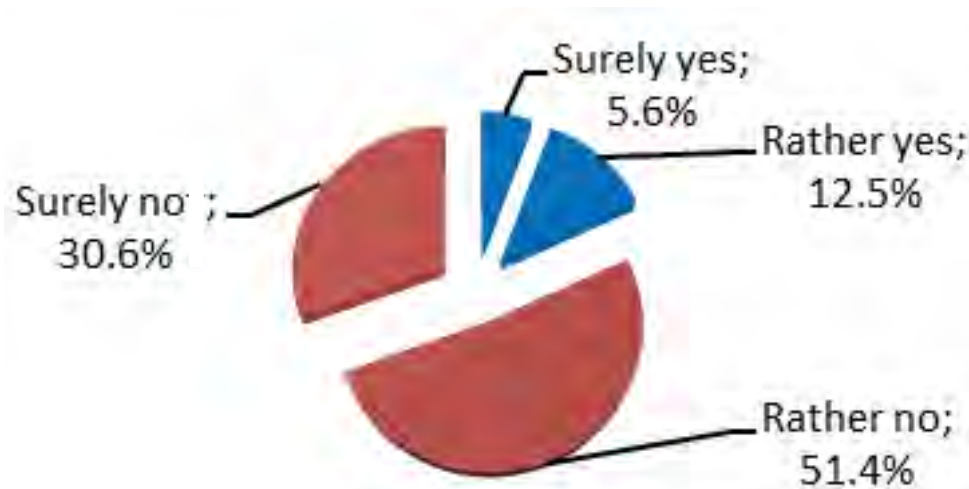

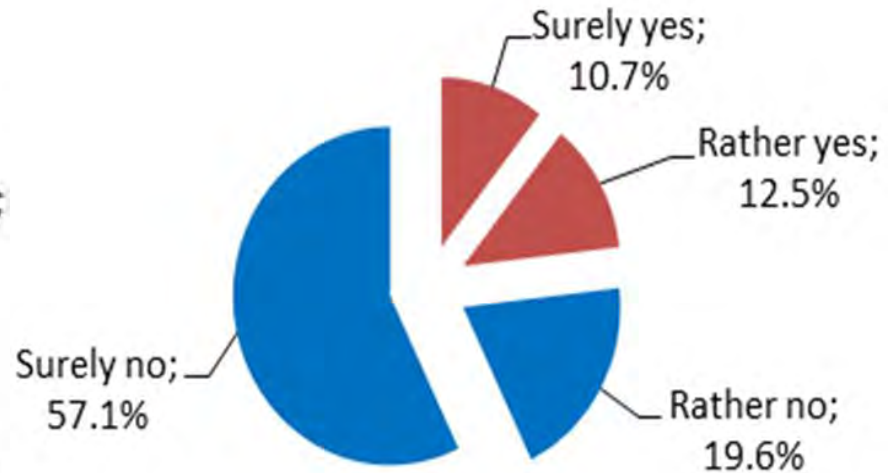


Do you think that the right to wear religious attributes and perform religious ceremonies in the educational institutions contradict with the federal legislation?

76.8% of respondents expressed their opinion that religious attributes do not infringe the rights and freedoms of other people



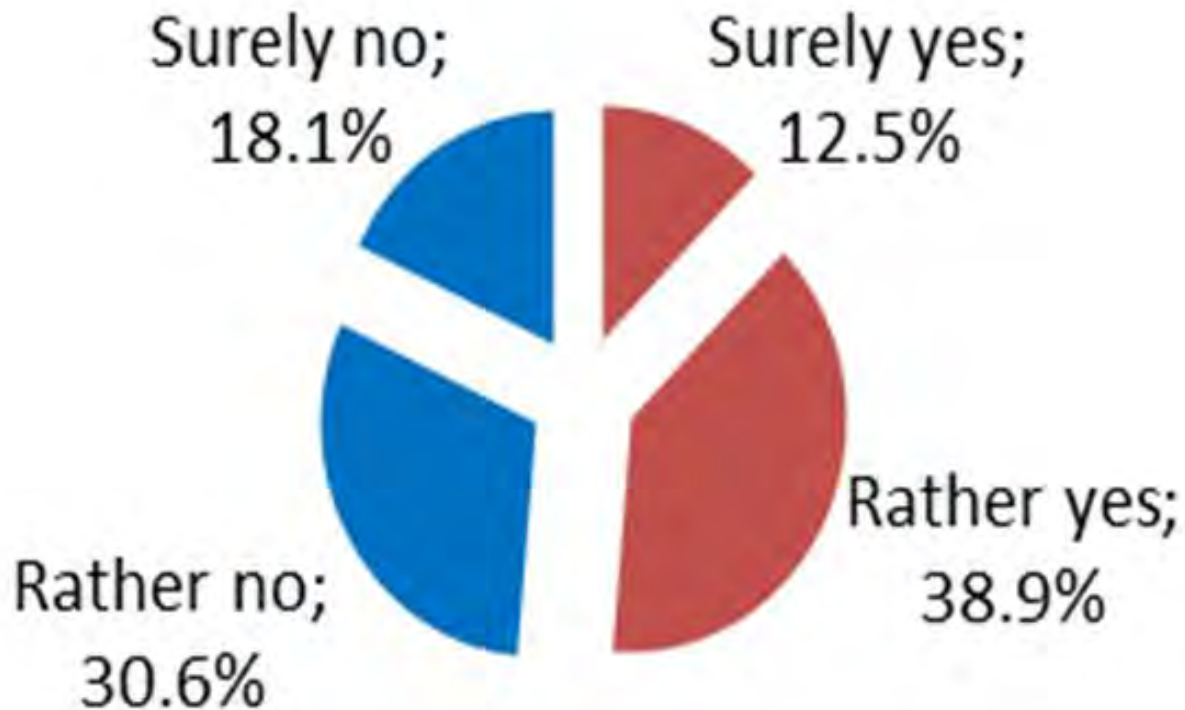

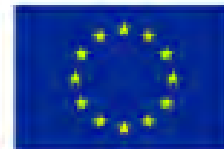
The main findings
